Limited Warranties - Dental Procedures Updated 2024

At Family and Cosmetic Dentistry of Kokomo, PC, it is our goal to satisfy each and every patient. We stand behind our work 100% and back it up with our warranty.

1. **Composite (tooth colored) Filings:** For a period of two years from the date of service, Dr. Jarrell & Associates will repair a composite filling due to breakage resulting from the dental procedure. In the rare occasion where a crown is required to repair the tooth, we will credit the cost of the filling towards a crown & crown build up.
2. **Veneers, Crowns and Bridges:** Five years from the date of service, we will repair a crown, veneer or bridge due to breakage. This is at no extra cost to the patient during the warranty period. It should be noted that porcelain crowns can chip, where gold crowns do not. Our warranty covers all chips on porcelain crowns for up to five years. Any repairs after that period will be assessed the regular fee.
3. **Root Canals:** While root canal therapy is highly successful, approximately 4% do fail. In such rare cases, it may be necessary to refer you to an endodontist, who specializes in these procedures. Dr. Jarrell & Associates will, during a two-year period from the date of service refund the cost of the unsuccessful root canal due to re-infection. If a root canal treated tooth cracks or fails due to incomplete treatment, then the warranty is void.
4. **Full and Partial Dentures:** 2 years from fabrication, we'll repair, free of charge, any break, crack, fracture, or tooth loss that results from a flaw in workmanship, at no cost to you. If you get a sore spot from your denture, we will be happy to make adjustments to relieve that discomfort through the term of the warranty. However, we will not reconstruct, repair, relin, or replace the denture, free of charge, due to any of the following: loss, discoloration, normal wear of denture teeth, neglect or abuse. Your warranty does not cover changes in gums and bones due to aging or weight changes which could result in ill-fitting dentures.
5. **Nightguards, TMJ and Snoring Appliances, Retainers, Flippers:** We will repair or replace the broken appliance for 6 months after fabrication. Dogs love appliances! If that happens, we will replace your appliance for ½ price.
6. **Implants:** 10 Year Warranty. In those rare instances when an implant does fail, corrective surgery such as bone and/or soft tissue grafting is often needed. If Dr. Jarrell has to remove one of her implants, she will replace the implant at no cost. Corrective procedures such as bone grafting or tissue grafting will be provided at ½ price. An implant is considered to be a failure if it becomes mobile or if it has progressive bone loss equal to or more than 50%.

**If an implant fails to integrate Dr. Jarrell will replace it at no cost, one time only. An annual implant examination including x-rays or regular dental cleanings in our office is an absolute requirement for this warranty to apply. This warranty does not apply to smokers or to persons who have, or who develop, an uncontrolled systemic health problem, such as, but not limited to, diabetes, autoimmune disorders, severe osteoporosis, or any condition requiring long term steroid or hormone replacement use.*

Warranties are contingent upon the patient maintaining all 4–6-month prescribed hygiene visits and recommended continuing care after the procedure has taken place. Warranty is void if recommended post treatment guidelines are not followed, (e.g., Not wearing night guard when prescribed).

Warranties are subject to change without notice.
